- For open/close ball valves 2-port and changeover ball valves 3-port, internally or externally threaded connections DN15 to DN25.
- Suitable for use with 2-position controllers.

Mounting

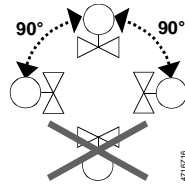

Commissioning

Manual adjustment

When commissioning the system, check both wiring and rotary actuator functions. The rotary actuator can be manually adjusted into any position between 0° and 90° by pushing the gear train disengagement slider.

If a control signal from the controller is present, this will take priority in determining the position after the slider is released.



For manual adjustment: Power off!

Electric, parallel connection of actuators

Up to 10 actuators of the same type can be electrically wired in parallel; cable length and cable cross-sections must be observed.

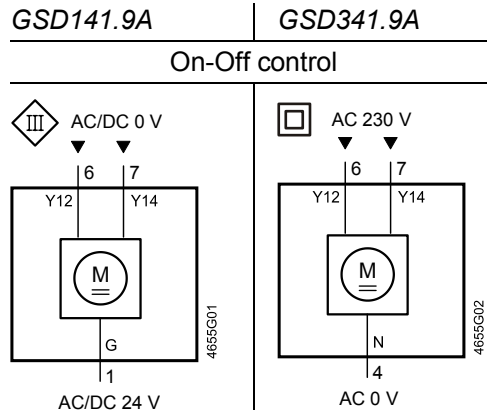

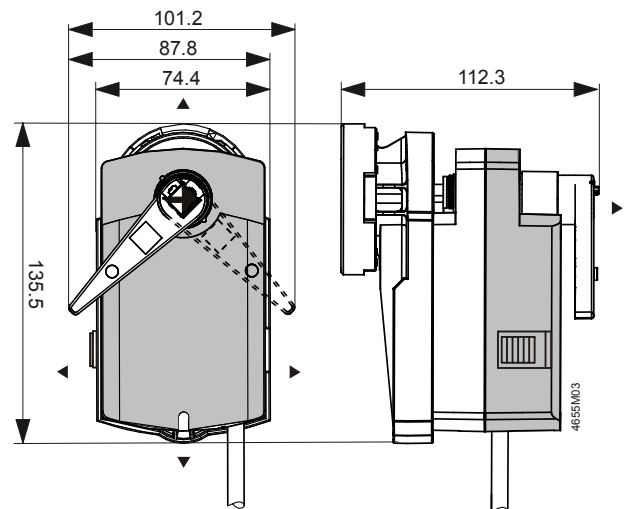
